ITM Akan Bagikan Dividen Tunai Interim Rp2.660 Per Lembar

ITM will Distribute an Interim Cash Dividend of Rp2,660 Per Share

Jakarta, 1 September 2023 – PT Indo Tambangraya Megah Tbk. akan melaksanakan pembagian Dividen Tunai Interim tahun buku 2023 sebesar USD 199 juta atau setara dengan Rp2.660 per lembar saham kepada pemegang saham. Dividen ini mewakili 65% dari Laba Bersih Perseroan yang dilaporkan sepanjang semester pertama 2023.

Pembagian Dividen Tunai Interim ini merujuk pada Keputusan Sirkular Direksi tertanggal 31 Agustus 2023 yang disetujui Dewan Komisaris Perseroan pada tanggal yang sama.

Dividen tunai interim akan dibagikan kepada pemegang saham yang namanya tercatat dalam Daftar Pemegang Saham Perseroan atau *recording date* pada tanggal 13 September 2023 dan/atau pemilik saham Perseroan pada sub-rekening efek di PT Kustodian Sentral Efek Indonesia (KSEI) pada penutupan perdagangan Bursa Efek Indonesia pada tanggal tersebut.

Jakarta, 1 September 2023 – PT Indo Tambangraya Megah Tbk. will carry out the distribution of an Interim Cash Dividend for the 2023 fiscal year amounting to USD 199 million or equivalent to Rp2,660 per share to its shareholders. This dividend represents 65% of the Company's Net Profit reported for the first semester of 2023.

The distribution of the Interim Cash Dividend refers to the Circular Resolutions of the Board of Directors dated August 31, 2023, which was approved by the Company's Board of Commissioners on the same date.

The interim cash dividend will be distributed to shareholders whose names are recorded in the Company's Shareholders Register (Recording Date) on 13 September 2023 and/or the owners of the Company's shares in the sub-account of securities at PT Kustodian Efek Indonesia (KSEI) at the close of trading on the Indonesia Stock Exchange on that date.
